This is a 40 hour block of instruction. He has room for 2 additional students from general industry. It will be held at Miller-Coors.

Suggestions for any training needs will be greatly appreciated. Steve Hale advises that industries will be contacted in the near future to update contact information and vitals. Johnny Bowles will be the contact. Steve Hale commented on what a good job Johnny is expected to do.

Emergency Management Report:

Joe Wright and Dennis Hancock have been promoted at NC Emergency Management.

Emergency Management Conference is being held on 10-24-10.

Johnny Bowles is currently working on grants. The initiative for training in areas of bioterrorism and gangs in schools is still on-going. PIO class is in the works.

Steve Hale reports that they did receive a grant for transfer switches to enable operation to continue in the event of power outage. Switches are going to be installed at M & M Recreation, Shiloh Community Building, and the county building department. Shiloh has graciously offered their shelter for special needs citizens for shelter. Thanks to Shiloh. In addition, as part of that grant Rock. Co received 2 generators.

EOC has a camera system and will be making changes on the county web page. This can be used with other community agencies that need to disseminate urgent communications to the public.

Steve Hale provided parting words, thanking everyone for their efforts and continued support of the LEPC and himself during his tenure in Emergency Management. He will retire December 31. He challenges everyone to continue the work of LEPC. Steve was commended for his service and helpfulness.
